Habitat for Humanity is a Christian housing ministry using private donations and volunteer labor to build homes with those in need of decent, affordable housing in Latah or Whitman County. We adhere to the spirit of federal fair housing law; anyone is welcome to apply no matter their personal beliefs or background. Habitat asks only that they meet the qualifications listed below.

Habitat is a hand up, not a handout. Future Habitat homeowners must save a share of closing costs, put in time to help build the home, attend classes and workshops designed to help them become successful homeowners. Applicant's total income must not exceed the maximum income guidelines listed below.

Please see the enclosed Homeownership Program summary for program requirements.

If you are interested in a Habitat home and believe you meet the requirements, I encourage you to fill out and return the application with the required additional documentation listed in the Application Checklist.

All information is considered confidential and will be used only for homeowner selection unless required otherwise by law. The application process may take up to three months.

If you do not hear from me within three days of the time you expect me to have received your application, please contact me to confirm that I received the application.

Applications must be postmarked by or turned into the office by 5:00pm on Monday, October 6th, 2025.
